The **Birth-to-five program** is funded by the Department of Education (DOE) and is free for all 3K and PK4 students. PKA program hours are 8:00 a.m. - 2:20 p.m., Monday through Friday.

The **Extended Day program** is **not** funded by the DOE and parents are required to pay for early arrival and late pickup. Same day payments are expected.

- 1. **Early arrival:** 7:00 a.m. – 7:55 a.m. Cost is \$5.00/day
- 2. **Late pickup:** 2:20 p.m. – 6:00 p.m. Cost is \$20.00/day

Parents may choose to enter a full year contract with the school for the Extended Day program, which covers both a.m. and p.m. hours. The cost of a full-year contract is \$2,250 per child (negotiated discounts for multiple children) or \$225 per month, with monthly payments commencing in September and ending in June.

**LATE PAYMENT PENALTY:**

Installment payments are due on the first business day of every month, with the first payment due in September. A grace period of five (5) business days is extended before late fees of \$40 are assessed monthly.

**RETURNED CHECK POLICY:**

The charge for each returned check is \$40 (subject to change). Upon one returned check for the academic school year, payments are thereafter required to be made using cash, money order, certified check, or credit card; MasterCard, Visa, Discover, and American Express are accepted by the school.
