DISCOUNT POLICY:

- 5% discount for signed contractual accounts (except extended day for 1st grade) paid in full by September 5, 2025.
- 3% discount for signed contractual accounts (except extended day for 1st grade) paid in full by October 3, 2025.

LATE PAYMENT PENALTY:

School payments are due on the first business day of every month. Payments begin in August with a grace period of five (5) business days. A late fee of \$40.00 will be charged thereafter. <u>Children are not allowed to attend classes, receive homework or participate in</u> <u>extra-curricular activities including school trips until all payments are current.</u>

RETURNED CHECK POLICY:

The charge for each returned check is **\$40** (subject to change). Upon <u>one</u> returned check for the academic school year, payments are thereafter required to be made using cash, money order, certified check, or credit card - MasterCard, Visa, Discover, and American Express are accepted by the school.

REFUND POLICY:

Refunds are granted for the following reasons and according to the schedule below. **Refunds will he issued 30 days from the date of the notification for the removal of the child/children.**

- Catastrophic illness of student;
- Relocation of parent(s) or guardian outside of the New York area;
- Disenrollment, initiated by the school

Evidence supporting illness or relocation must be provided to the school prior to the completion of the refund process.

The basis of computing a tuition refund is the monthly installment amount paid prior to the withdrawal month as shown on the Payment Schedule, less the monthly installment amount divided by the number of school days in the month, times the number of days the child was in school during the month.

Tuition refunds will also be made, net of the withdrawal penalty. For example, if a parent enrolled his/her child in Grade 1 and has paid the monthly tuition due for September and October 2025 but later decides to withdraw the child from school any day from October 1- 31; the penalty will be 50% of the monthly installment amount. If the installment was not paid for the month of withdrawal, such tuition and penalty must still be paid in full to the school before records are released.

Example 1:

Tuition Grade 1 - \$7,290 per child - If the child withdraws from school on October 7, 2025, and tuition paid in advance for the month of October totaled \$729, tuition refund before penalty applied would be\$530.24 (22 school days in the month with 16 days unattended or 729/22 x 16). The withdrawal penalty would be \$364.50 (50% of the monthly installment) and therefore the net refund would be \$165.74. Refund is calculated based on the number of school days within a month.

There are no exceptions to the refund policy

LUNCH PROGRAM: Lunch is included in the tuition for Kindergarten and Grade 1 students.

EXTENDED DAY PROGRAM: Extended Day is included in the tuition for K students

- Extended day hours: 3:00 pm to 6:00 pm for all grades (K and 1st) and 2:20 pm to 6:00 pm for 3K & PK4 students
- Extended day may be purchased separately at a rate of \$20.00 per day for all grades.
